

## Scottsmoor Community Association Meeting Minutes for November 26, 2012

The meeting was called to order at 7:00 PM by President, Arnold Benson. A potluck dinner was held prior to the meeting featuring different soups and a ham cooked by Corrine Stokes. There were 38 people at the dinner, and 34 at the meeting. Vice President Robert Robbins led the Pledge of Allegiance and President Benson asked for a moment of silence. Officers present included President Arnold Benson, Vice President Robert Robbins, Treasurer Bryan Kyle, Secretary Lee Bird and Executive Committee Member Doug Chamberlain. Executive Committee Member Marianne Syverson was absent.

**Introduction of Visitors and Guests** – No visitors or guests were recognized.

**Minutes** - The minutes from the previous meeting were read by Lee Bird, Secretary. Doug Chamberlain moved that the minutes be approved as read, and Dietmar Unger seconded the motion. The motion was approved.

**Treasurer's Report** – Bryan Kyle reported that our current balance is \$10,114.38. Doug Chamberlain moved that the Treasurer's Report be accepted as read and Bobbi Partain seconded. The motion was approved.

### Committee reports

**Meeting Hall** – Lee Bird reported that attendance at the meeting hall for October was 468. He discussed the December & January calendars paying particular attention to the dates for the upcoming parades and our Christmas party.

**Public Relations** – Doug Chamberlain reported that cards were sent to Rinda Chapman and Terry Syverson.

**Website** – No Report was offered.

**Membership Committee** – Bryan Kyle reported we have 121 paid members for 2012, and 4 paid members for 2013. He reminded us that memberships expire at the end of the calendar year, and he can accept 2013 dues at any time.

**Mims Report** - Ron Barchar Announced that plans were moving along for an ice cream parlor on US 1 near the Post Office in Mims. He also reported that rumors exist about a Walmart store in Mims, but nothing can be confirmed.

**Special Events** – President Benson asked for volunteers to decorate the hall on Friday, December 14 at 6PM. He mentioned that judging for the 6<sup>th</sup> Annual Festival of Lights will begin on Monday, December 10, and prizes will be awarded to the winners at our Christmas dinner. The prizes will be gift certificates for \$50, \$40 and \$30. He also discussed the upcoming parades and asked for candy donations for the parades. The Christmas Party was discussed and Robert Robbins reminded the membership to bring an unwrapped toy for the Toys for Tots program.

**New Business** – Doug Chamberlain moved that the Association buy a 2000w Honda generator for use on the Christmas float, and Charlie Stokes seconded the motion. The motion carried. Bill Partain announced that there was a possibility of the County

evacuating or truncating Dixie Way to accommodate the proposed Veterans Cemetery in Scottsmoor. President Benson asked Bill to keep us informed of developments.

**Other Considerations** – President Benson asked for volunteers for the January Pot Luck, but no one spoke up. He also announced that the Quarterly Attendance Drawing would be held at the Christmas Party and you must be present to win.

**50/50** –The 50/50 raffle was won by Dale Ceballos. The split was \$19.50 to Dale, and \$19.50 to the Association.

**Adjournment** – The motion to adjourn was made by Dietmar Unger at 8:02 PM.
